## A summary of the principal required terms and conditions of the procurement contract or the framework agreement:

Petrojam Limited is a limited liability company, jointly owned 51 percent by the Petroleum Corporation of Jamaica, a statutory body created and wholly owned by the Government of Jamaica and 49 percent by PDV Caribe, a subsidiary of Petroleos de Venezuela (PDVSA). The company's core business is the use of hydro-skimming process to refine crude oil into finished products (diesel oil, gasoline, asphalt, kerosene, LPG, etc). Petrojam currently operates a simple hydro-skimming refinery with nameplate crude processing capacity of 36,000 bpsd. The company's operations include procuring crude oil and finished petroleum products; and refining crude oil to produce liquefied petroleum gas (LPG), gasoline, kerosene, jet A1 fuel, diesel, fuel oil and asphalt. Petroleum imports (crude oil and finished products) are received via one of two main docking facilities. Products are distributed through multiple loading terminals located in Kingston and Montego Bay. In addition, a dry dock exists for import and export of asphalt. Petrojam also operates a petroleum testing laboratory.

At present, approximately 50 percent of the output from the refinery is Heavy Fuel Oil (HFO). Due to declining HFO markets and impending changes to the bunker fuel specifications (January 2020), Petrojam will advance installation of a new Vacuum Distillation Unit (VDU), which was originally planned as a part of a larger project to upgrade the entire refinery. The new

VDU with associated utilities and off-sites will convert the HFO produced into vacuum gas oil (VGO) and asphalt. The target commissioning date for the new VDU with associated utilities and offsites – the VDU Project – is March 2020. The Project is expected to cost approximately US\$100 million.

Petrojam now seeks to prequalify suitable and interested consulting firms who once qualified according to the criteria described in this prequalification document, will be invited to tender for the substantive contract to provide project management consulting services. These services will be provided on an “as-required” basis to supplement Petrojam’s Project Management Team leads.
